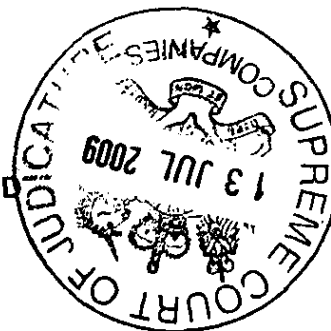

- (B) inform the Registrar of Companies immediately on the conclusion of the said proposed litigation or any appeal therefrom or on the conclusion of the claim by any other means

AND UPON the solicitors for the Claimant and for the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED THAT:

- (1) the name of the above named Metal Containers Limited be restored to the Register of Companies
- (2) the company's number (559358) do appear with the name of the company in the Register maintained by the Registrar of Companies and that the Registrar do add the company's number to its name in such places where he records the name of the company pursuant to his statutory functions as he shall think fit for the purpose of drawing the attention of the public to the existence of the incorporation of another company under the same name.
- (3) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the company is thereupon to be deemed to have continued in existence as if its name had not been struck
