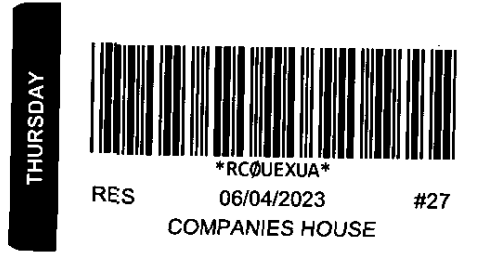

And it appearing that there is no opposition on behalf of His Majesty to the relief sought by this claim as appears from the Evidence of Service of Kamran Ellahi and the exhibit hereto

And on leave being given to amend the Claim Form to show the correct name of the company as Williams Lea UK Ltd and re service being dispensed with

And the claimant by his solicitors undertaking to:

A) Immediately on the restoration of the company to the Register inform the Registrar of Companies of the title and court reference number of the litigation issued against the company referred to in paragraph 9 of the Witness Statement of Kamran Ellahi dated 16th November ~~2023~~: 2022

B) Inform the Registrar of Companies immediately on the conclusion of the said litigation insofar as it is against the company or of any appeal therefrom or on the conclusion of the claim against the company by any other means. And upon the solicitors for the claimant and the Registrar of Companies (the defendant) both consenting to this order.

IT IS ORDERED THAT

1. the name of the above Williams Lea UK Ltd be restored to the Register of Companies.
2. if at the date of registration of this order with the Registrar of Companies the name of the company is not available the Registrar of Companies shall pursuant to section 1033(2)(a)(ii) and (b) of the Companies Act 2006 restore the company as "Company 01650602 Limited."
3. An office copy of this order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the company is thereupon to be deemed to have continued in existence as if its name had not been struck off.
4. the Registrar of Companies do advertise notice of this order in her official name in the "London Gazette"
5. the claimant do pay the Register of Companies her costs of the said application in the agreed sum of £300.00.
