- (B) inform the Register of Companies immediately on the conclusion of the said litigation insofar as it is against the Company or of any appeal therefrom or on the conclusion of the claim against the Company by any other means

AND UPON the solicitors for the Claimant and for the Registrar of Companies (the Defendant) both consenting to this Order

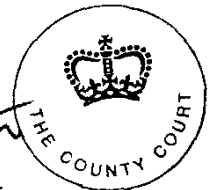
