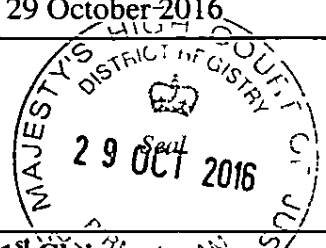

**AND** the Claimant by her Solicitors undertaking to

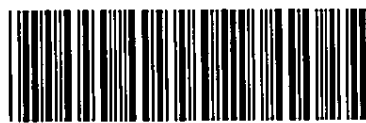
