UPON THE APPLICATION by a Claim Form dated the 15<sup>th</sup> May 2017 of The Commissioners for Her Majesty's Revenue and Customs the Claimant and a creditor of the above named Boku Properties (hereinafter called "the Company")

AND UPON READING the evidence

AND IT APPEARING that there is no opposition on behalf of Her Majesty to the relief sought by this Claim as appears from the Waiver Letter from the Treasury Solicitor dated the 20<sup>th</sup> June 2017

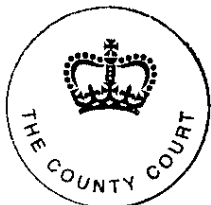
AND the Claimant undertaking to:

WEDNESDAY



(A) inform the Registrar of Companies of Title and reference number of the Appeal made by the Company to the first Tier Tax Tribunal against the Assessment of the Company's liability for stamp Duty Land Tax as referred to in paragraph 17c of the Witness Statement of Amanda Maria Green dated the 12<sup>th</sup> May 2017 (the Witness Statement)

(B) promptly inform the Registrar of Companies of the final determination (being the point at which no further appeal may be brought before any



Court by either party) of such appeal

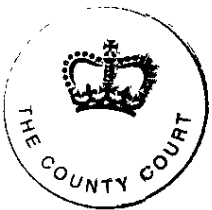
- (C) should such final determination be in its favor, and if the Company does not make full payment within 28 days after such determination, serve upon the Company a final demand for payment
- (D) within 28 days after service of a final demand, the Claimant will inform the Registrar whether payment has been made
- (E) if payment is not made in full within that time the Claimant will also, within 56 days after service of final demand, present a petition to the Court for the compulsory winding up of the Company and provide particular of that petition to the Registrar
- (F) within 14 days of any compulsory winding up Order in respect of the Company the Claimant will deliver an Office Copy of that Order to the Registrar of Companies
- (G) if no Order is made compulsory winding up the company in the interim, at six monthly intervals from the date of the Order the Claimant will serve on the Registrar of Companies a full and sufficient Witness Statement setting out what progress there has been winding up the company
- (H) if, at any point the Claimant decides that it will not pursue the Company (either because the money has been paid or because the shareholders have made no challenge to the assessment issued to them), the Claimant will promptly notify the Registrar



AND UPON the Solicitors for the Claimant for the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED that:

- (1) the name of the above named Boku Properties be restored to the Register of Companies
- (2) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 06708702
- (3) an Office Copy of this Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the company is thereupon to be deemed to have continued in existence as if its name had not been struck off
- (4) the Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette"
- (5) the hearing date fixed for the 17<sup>th</sup> August 2017 be vacated


