**1 Director's benefits: advances, credit and guarantees**

Included in the current assets is a loan to the directors of £18,079 (2023 : £70,570). Advances in the year amounted to £6,445 with amount repaid totalling £59,840. An interest rate has been charged at HMRC's official rate over the year. The loan is unsecured and repayable upon demand.
