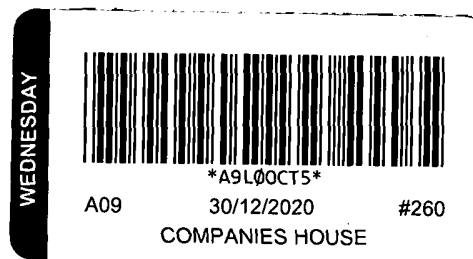

1. Average employees
