**NOTES TO THE FINANCIAL STATEMENTS
FOR THE PERIOD 30 JULY 2023 TO 31 JULY 2024**

1. STATUTORY INFORMATION

2SALS Limited is a private company, limited by shares, registered in England and Wales. The company's registered number and registered office address can be found on the Company Information page.

2. ACCOUNTING POLICIES

Basis of preparing the financial statements

These financial statements have been prepared in accordance with Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" including the provisions of Section 1A "Small Entities" and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Stocks

Work in progress is valued at the lower of cost and net realisable value.

Cost is calculated using the first-in, first-out method and includes all purchase, transport, and handling costs in bringing stocks to their present location and condition.

Taxation

Taxation for the period comprises current and deferred tax. Tax is recognised in the Income Statement, except to the extent that it relates to items recognised in other comprehensive income or directly in equity.

Current or deferred taxation assets and liabilities are not discounted.

Current tax is recognised at the amount of tax payable using the tax rates and laws that have been enacted or substantively enacted by the balance sheet date.

Deferred tax

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date.

Timing differences arise from the inclusion of income and expenses in tax assessments in periods different from those in which they are recognised in financial statements. Deferred tax is measured using tax rates and laws that have been enacted or substantively enacted by the period end and that are expected to apply to the reversal of the timing difference.

Unrelieved tax losses and other deferred tax assets are recognised only to the extent that it is probable that they will be recovered against the reversal of deferred tax liabilities or other future taxable profits.

Going concern

At the year end the company had net liabilities of £1,478 and is therefore dependent on the continued financial support of the shareholders.

3. EMPLOYEES AND DIRECTORS

The average number of employees during the period was 2.

4. DIRECTORS' ADVANCES, CREDITS AND GUARANTEES

During the year, the directors provided an unsecured interest free loan to the company with no fixed repayment date. At the year end the balance was £144,878.

5. RELATED PARTY DISCLOSURES

During the year ISAL Ltd, a company also owned by Mr I Saleh provided an unsecured interest free loan of £25,000 with no fixed repayment date.
